AND NOW, November 16, 2015, there has been no activity in the cases on the attached list for a significant period of time. Pennsylvania Rule of Judicial Administration 1901(a) authorizes this court to terminate a matter that has been inactive for an unreasonable period of time. However, before terminating a matter on this basis, the parties must be given at least thirty (30) days written notice of opportunity for hearing, pursuant to Pa.R.J.A.1901(c).

All parties are hereby notified of the opportunity for hearing on the proposed termination of their case. Parties may request a hearing by filing a written motion with the Prothonotary of Clarion County not later than February 22, 2016.

The party filing a motion shall state in the motion the reasons for the delay in the prosecution of the case, the specific actions the party will take to bring the case to a conclusion as promptly as possible, and a realistic time frame for final conclusion of the case.

Copies of the request for hearing shall be served by the filing attorney or by the unrepresented party on all other attorneys of record and upon all unrepresented parties at their address of record by regular first class mail, prior to the hearing date.

If no party files a request for hearing by February 22, 2016 the court will issue an Order dismissing those cases for failure to proceed.

If a request for hearing is filed, a hearing will be held by this court on Tuesday, March 22, 2016 at 9:00 a.m. in Courtroom No. 1, Clarion County Courthouse. The court has set aside the full day for hearings. The attorney for the party requesting a hearing, or if there is no attorney of record then the party himself/herself, shall attend the hearing in person and show good cause why the case should not be terminated. Other attorneys or parties who desire to participate in the hearing shall also attend in person. After the hearing, the court will enter an appropriate Order, either directing the action to be taken by a party or parties or dismissing the case with prejudice.

The Prothonotary shall serve copies of this Order of Court upon counsel of record, and upon the parties for whom no appearance has been entered, as provided by Pa.R.J.A.No.1901(c). Notice shall also be placed one time in The Derrick newspaper and this Order and the list of cases being considered for termination shall be published on Clarion County's website at <http://www.co.clarion.pa.us/images/stories/pdf/Courts/CivilDocketTerminationList.pdf> under Civil Docket Termination.
