

## INVITATION FOR BID

The Board of Clarion County Commissioners is issuing an invitation to bid for surplus vehicles as listed below. Bids must be valid for 30 days. Bid submittal forms are available from 9:00 am to 4:00 pm, Monday – Friday in the office of the Commissions at the Clarion County Administrative Building, 330 Main Street 2<sup>nd</sup> Floor, Clarion, PA 16214.

**Bids are due to the Office of the Chief Clerk, in the Commissioners' Office, 330 Main Street, 2<sup>nd</sup> Floor, Clarion, PA 16214, by 4:00 p.m. Monday, June 27, 2016.** Bids will be opened at the Commissioners' regular business meeting starting at 9:00 am on Tuesday, June 28, 2016, in the Commissioners' Conference Room.

### Details:

- **A 10% deposit is required with each sealed bid.**
- **A bid may contain only one vehicle bid request per envelope.**
- **Bids must be in a SEALED envelope with the year, make and the last four of the VIN number of the vehicle listed on the outside of the envelope.**
- **Once the bid is awarded the person who receives the bid is required to make final payment and pay for all notary and transfer fees within ten days of notification of the award.**
- **Any bid not accepted, the deposit will be returned.**
- **All monies must be a certified check or money order made payable to: County of Clarion.**
- **The bidder has until July 9 to remove the vehicles from county property after notification of award of the bid.**
- **All sales are final and the vehicles are sold as is.**
- **The County has the right to reject any and all bids.**
