

A RESOLUTION CREATING A COUNTY PLANNING COMMISSION, DEFINING THE POWERS
B SAID COMMISSION, MEMBERSHIP AND GRANTING SAID COMMISSION THE ADDITIONAL
POWER AND DUTY OF SERVING AS THE COUNTY ZONING COMMISSION.

WHEREAS, the Board of County Commissioners of Clarion County
are authorized by Section 2001 of P.L. 323 dated August 9, 1955 to create a
county planning commission and to give to said commission the additional
power of serving as a county zoning commission; and

WHEREAS, the Commissioners of Clarion County recognize the
need for a planning program on a county-wide basis in Clarion County.

NOW, THEREFORE, BE IT RESOLVED, the Commissioners of Clarion
County hereby create a county planning commission to be known and designated
as The Clarion County Planning Commission and to have and to hold
all the powers and privileges given to County Planning Commissions by the
County Code and amendments thereto; and

BE IT FURTHER RESOLVED, that said Clarion County Planning Com-
mission shall have the additional power and duty of serving as the county
zoning commission with all the powers and duties given to a county zoning
commission by the above Act of Assembly and amendments thereto; and

BE IT FURTHER RESOLVED, that said County Planning Commission shall con-
sist of nine members who shall be residents of Clarion County. Said
members shall be appointed for terms as set forth in the above stated Act of
Assembly.
